RFP for Widening of existing 2 lane to 4 lane divided carriageway with paved shoulder from "Design Km 0+000 (Ex Km 99+924 on NH-347BG) near Deshgaon to Design Km 51+579 (Ex Km 77+500 on SH-26) of NH 347B near Dewalgaon (Design length=51.579kms)" under NH(O) in the State of Madhya Pradesh on Hybrid Annuity Mode

The Government of India had entrusted to the Authority the development, maintenance management and Widening of existing 2 lane to 4 lane divided carriageway with paved shoulder from "Design Km 0+000 (Ex Km 99+924 on NH-347BG) near Deshgaon to Design Km 51+579 (Ex Km 77+500 on SH-26) of NH 347B near Dewalgaon (Design length=51.579kms)" under NH(O) in the State of Madhya Pradesh on Hybrid Annuity Mode thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. However, Bid Security, Power of Attorney for signing of Bid, Power of Attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any, and other documents required as per clause 2.11.2 of RFP shall be submitted physically in original by the Lowest Bidder before issuance of Letter of Award (LOA) by the Authority. However, while submitting Bid Security via Account Payee demand draft or Banker's cheque or Fixed Deposit Receipt, it is to be ensured by the Bidder that Account Payee demand draft or Banker's cheque or Fixed Deposit Receipt are submitted physically latest within 5-working days of the Bid Due Date (upto 11:00 hours).
