The National Highways Authority of India (NHAI) hereby invites bid through e-tendering from experienced firms/ organizations for short-term improvement and routine maintenance contracts for the following sections of the National Highways: -

The scope of work includes Operation & Maintenance of four Laning of Kutchery chowk Ranchi-Piska More-Bijupara Section of NH- 75 (from Km.3+ 560 to Km. 55+000) & Piska More-Palma Section of NH-23 (from Km.3+600 to Km.26+000) (Length of 72.67 Km) in the state of Jharkhand. It is mandatory for all the bidders to have class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption in the name of authorized signatory (who will sign the Bid)) from any of the licensed Certifying Agency (Bidders can see the list of licensed CA's from the link www.cca.gov.in to participate in e-tendering of NHAI.

To participate in the e-bid, it is mandatory for the Applicants to get themselves registered with the NHAI

e-Tendering Portal (<https://etenders.gov.in>) to have a user ID & Password. The detailed tender document can be viewed from the website <https://etenders.gov.in> or www.nhai.org/www.nhai.gov.in from 12.06.2025 to 26.06.2025.

The complete Bid Document can be downloaded from the NHAI e-tendering portal free of cost. To participate for bidding, bidders have to attach scan copy of receipt in online submission after paying a non-refundable document fee online through NEFT/RTGS in the account as mention below:-

The bid should be submitted online in the prescribed format given in the website. No other mode of submission is acceptable.

The bidder has to submit self-declaration and other applicable documents in support of eligibility as Class-I/II Local Supplier as per Public Procurement (Make in India) Order 2017 as amended on 16-09-2020.

If the Bidder is belonging to any neighbouring country sharing land Border with India, the Bidder needs to be registered with appropriate Competent Authority as per GFR Rule 144 (xi).

The authorized signatory holding Power of Attorney shall only be the Digital Signatory. In case authorized signatory holding Power of Attorney and Digital Signatory are not the same, the bid shall be considered non-responsive.

The last date submission online is 26.06.2025 up to 11.00 Hrs (as mentioned on the e-portal only) ("Bid Due Date"). The bids shall be opened on 27.06.2025 at 11:30 hrs online at RO-Ranchi, C-129, Vidyalaya Marg, Ashok Nagar, Ranchi. The physical documents of all bidders must reach this office within 7 days of declaration of results of tender, failing which the defaulting bidder may be debarred/ blacklisted from NHAI works for a period of 5 years. In case of change of venue, due intimation will be made to all the participants. Representatives of the bidders (maximum of two) who choose to attend may participate the online opening of the bids at NHAI, RO Ranchi on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letterhead of the bidder, at the time of opening of bids as mentioned above.
